Our Club Constitution requires that dues shall be payable **on or before January 1 of each year**. Your dues support the club's activities during the year, such as the Spring Match, Fall Fun Day, and the Holiday party, as well as tattoo and microchip clinics, the newsletter and associated mailing costs. Some of you are exempt (life members, new rescue families, those who joined in September or later in 2009), but we would appreciate it if you would still return the form below for our records. The rest of us need to pay our dues - the Bull Terriers need your support.

**Please NOTE: Since we have affiliated with the American Kennel Club, we are now offering 3 types of memberships, Regular, Household, and Associate. Per our constitution Article 1 section 1.**

*"Eligibility: There shall be three types of membership available:*

- **Regular** (individual)-enjoys all club privileges including the right to vote and hold office.
- **Household-Two** (2) adult members residing in the same household, each eligible to vote and hold office.
- **Associate or Newsletter**-Entitled to all club privileges except voting and office holding. "

On November 15, 2006 the board of directors voted to increase the dues for associate and regular membership by \$5.00-we have not increased our dues in over 7 years, and the cost of doing business has increased.
